- The Challenger Learning Center of Alaska (CLCA) is not responsible for any lost or stolen items that your camper brings to camp; please label all belongings.
- Discounts available for families with more than one camper. Contact for details during registration process.
- Minor campers will ONLY be released to their parent/guardian or individuals listed on this form. NO EXCEPTIONS. Photo identification will be required of all at the time of pick up.
- All medications your child brings to camp MUST be listed on this form. This includes prescriptions, medications, lotion, and ALL over-the-counter medication and/or vitamins. Medications must come in the ORIGINAL packaging/prescription bottle, and will be dosed ONLY according to the label's directions. All medications will be stored in the First Aid station. At CLCA's sole discretion, on a case-by-case basis, the only medications to be carried by campers are those that require immediate administration, such as rescue inhalers, insulin, and/or Epi-pens.

**FEE AND CANCELLATION INFORMATION:**

- Pay in full 60 days prior to camp start date and receive a \$20 discount.
- Payment plans are available.
- Camp fees are due, in full, two weeks prior to camp start date.
- There is a late registration fee of \$25 for payment within 2 weeks of the camp date.
- Campers remaining after published end of camp will incur a \$50 childcare fee per hour.
- Cancellations less than two weeks prior to camp start date and no-shows are non-refundable.
- There will be no refunds or credits for early departure from camp, *regardless of reason*.
- CLCA reserves the right to cancel if minimum enrollment is not met for camp. (Preregistered campers will be given a full refund). Notification of cancellation will be sent 7-10 days before the start date.
